

## COVID-19 UPDATE

It is very important to Australian Boat Safe Licence College management to minimise the risk to our Students and Trainers during the COVID-19 situation.

### **Advice to Students and your upcoming Licence training & assessment:**

Please postpone your booking for a minimum of 14 days and seek medical advice if:

- You are currently unwell (fever, cough, sore throat, fatigue or shortness of breath);
- You develop symptoms; and
- You have been in close contact with a person known to have COVID-19 or live in or have recently travelled from an area with ongoing spread of COVID-19.
- You're involved in Health Contact Tracing or subject to Self Quarantine Order

### **MINIMISING RISK:**

As well as the government public and industry advices being distributed regarding the virus, below are the precautions relevant to Boat and Personal Watercraft (jetski) students for our Marine courses.

- FYI—we have reduced the number of students on our course;
- Please, NO hand shaking;
- We will provide access to hand washing / hand sanitising throughout the duration of the Training & Assessment Course and ask students to thoroughly wash / sanitise their hands before and throughout the duration of the course where practical;
- We will maintain distance between each Student and Trainer (where practical) throughout the Training & Assessment Course (see important information for Boat & Jetski assessment below);
- Students should bring their own pens for exams for their own personal use
